

# SpaceX IPO入金優惠條款與細則



## 前言

本條款與細則（「促銷條款」）構成SpaceX IPO入金優惠（「優惠」或「促銷活動」）不可分割的一部分，參與前請務必完整閱讀。

本優惠將於2026年6月8日週一英國夏令時間（BST）00:01開始，適用於TF Global Markets (STL) Limited（「智匯」、「本公司」、「我們」）符合資格的新客戶。參與本優惠須遵守本促銷條款。

本促銷條款為本公司一般客戶協議的補充條款，並不修改該協議。一般客戶協議的所有條款仍繼續完整適用。如本促銷條款與一般客戶協議之間存在任何衝突，僅就本優惠而言，應以本促銷條款為準。

## 一、 促銷期間

- 1.1 本優惠將於2026年6月8日週一英國夏令時間（BST）00:01開始。
- 1.2 您必須於2026年6月12日週五英國夏令時間（BST）下午2:30前完成帳戶入金並提交申請（「申請截止時間」）。
- 1.3 您必須於2026年6月30日英國夏令時間（BST）23:59前完成所屬級別的合資格交易（「交易截止時間」）。
- 1.4 SpaceX預計將於2026年6月12日週五在納斯達克（Nasdaq）以股票代號SPCX開始交易。上市日期由SpaceX及其承銷商決定，並可能變更。如上市延遲或未能進行，我們可根據第十節修改或撤回本優惠。

## 二、 參與資格

如欲參與，您必須符合以下條件：

- 2.1 為促銷期間內帳戶獲批的新客戶。
- 2.2 從未持有智匯已入金帳戶。如您目前持有或曾經在任何實體下持有智匯已入金帳戶，則不符合資格。
- 2.3 於促銷期間內完成合資格首次入金。
- 2.4 於申請截止時間前提交有效申請（請參閱第五節）。

每位客戶僅可提交一次申請。我們會透過已驗證身分、付款方式及裝置識別客戶。多個帳戶、共用資金來源或關聯裝置均視為同一位客戶。智匯員工、介紹經紀商及其關聯人士均不符合參與資格。

### 三、 優惠內容

為您的帳戶入金後，我們將根據您的首次入金金額，向該帳戶分配相應數量的SpaceX股票差價合約：

首次入金金額(美元)	可獲得的SpaceX股票差價合約數量
\$250至\$999	0.1
\$1,000至\$2,499	0.5
\$2,500至\$4,999	1.5
\$5,000或以上	4.0

分配上限為4.0手SpaceX股票差價合約。入金超過\$5,000的客戶同樣獲得4.0手分配。您的級別將根據首次入金金額決定，日後再次入金不會改變該級別。

SpaceX股票於IPO時的價格約為\$135。此數字僅供參考。我們按各級別分配固定數量的SpaceX股票差價合約，而非固定現金價值，因此您的分配價值會隨市場價格波動。

### 四、 如何申請

- 4.1 完成您的首次入金。
- 4.2 於入金後、申請截止時間前，使用您的註冊電子郵件地址發送電子郵件至 [support@thinkmarkets.com.cn](mailto:support@thinkmarkets.com.cn)，說明您希望申請SpaceX優惠。
- 4.3 在您的入金款項完成入帳，且SpaceX股票差價合約可供交易後，我們將處理有效申請並分配SpaceX股票差價合約。

申請截止時間後收到的申請將不被接受。

### 五、 分配內容

- 5.1 我們會將SpaceX股票差價合約作為多頭（買入）持倉分配至您的交易帳戶。您將持有該持倉，並承擔相關市場風險。其價值可能上升或下跌。
- 5.2 該分配將保持鎖定，直至您滿足第七節所述的解鎖條件。於鎖定期間，如您提取資金，將失去該分配（請參閱第八節）。

### 六、 解鎖分配

如欲保留分配並解除出金鎖定，您必須於交易截止時間前完成所屬級別的合資格交易：

首次入金級別	合資格交易
\$250至\$999	1手外匯或黃金，或10手SpaceX股票差價合約
\$1,000至\$2,499	2手外匯或黃金，或20手SpaceX股票差價合約
\$2,500至\$4,999	3手外匯或黃金，或30手SpaceX股票差價合約
\$5,000或以上	5手外匯或黃金，或50手SpaceX股票差價合約

- 6.1 合資格交易必須以您自己的資金進行，並與分配內容分開計算。我們分配給您的SpaceX股票差價合約不計入合資格交易。
- 6.2 合資格交易必須至少持倉5分鐘。
- 6.3 完成合資格交易後，該分配即歸您所有。出金鎖定將被解除，您可自行選擇持有、平倉或交易該SpaceX股票差價合約，並可按您的意願提取資金。

## 七、 出金與失去分配

- 7.1 如您在完成合資格交易前提取任何資金，我們將從您的帳戶中移除 SpaceX 股票差價合約分配，或移除該分配於移除當時的現金價值。
- 7.2 如您未能於交易截止時間前完成合資格交易，我們將從您的帳戶中移除該分配，或移除該分配於移除當時的現金價值。

完成合資格交易後，本優惠項下將不再適用任何出金限制。

## 八、 反濫用條款

如我們合理認為客戶存在以下情況，我們可拒絕或移除分配，並關閉或限制其帳戶：

- 8.1 開立多個帳戶，或使用多個身分、付款方式或裝置，以重複申請本優惠。
- 8.2 僅為申請並提取優惠而入金，且無真實交易意圖。
- 8.3 使用旨在滿足合資格要求但不承擔市場風險的交易，包括在不同帳戶之間進行匹配或對沖持倉。
- 8.4 提供虛假資料或以其他方式濫用本優惠。

我們對參與資格、合資格交易及分配失效的判定為最終決定。

## 九、 一般條款

- 9.1 我們可隨時修改、暫停或撤回本優惠，包括但不限於 SpaceX 上市延遲、變更或取消，或基於法律、監管或營運原因。
- 9.2 除非本條款規定於移除時以現金價值處理，否則本優惠不得兌換為現金。

如本條款與本公司一般客戶協議存在衝突，僅就本優惠而言，應以本條款為準。

## 十、 管轄法律

本促銷條款受客戶持有帳戶之智匯持牌實體所適用的標準計畫條款中相同的管轄法律及司法管轄權條款約束。

## 十一、 風險警告與監管資訊

交易差價合約及外匯對您的資本具有高度風險，未必適合所有投資者。差價合約屬於複雜金融工具，因槓桿作用可能導致資金快速虧損，風險較高。您可能損失超過初始入金金額。請確保您充分了解相關風險，並在必要時尋求獨立建議。

# SpaceX IPO Deposit Offer Terms and Conditions



## Introduction

These Terms and Conditions (the “Promotion Terms”) form an integral part of the SpaceX IPO Deposit Offer (the “Offer” or “Promotion”) and should be read in full before participation.

The Offer opens at 00:01 BST on Monday 8 June 2026 and is available to eligible new clients of TF Global Markets (STL) Limited (“ThinkMarkets”, the “Company”, “we”, “us”). Participation is subject to these Promotion Terms.

These Promotion Terms operate in addition to, and do not amend, the Company’s general client agreement. All terms of the general client agreement continue to apply in full. In the event of any conflict between these Promotion Terms and the general client agreement, these Promotion Terms shall prevail solely in respect of this Offer.

## 1. Promotion period

- 1.1 The Offer opens at 00:01 BST on Monday 8 June 2026.
- 1.2 You must fund your account and submit your claim by 2:30pm BST on Friday 12 June 2026 (the “Claim Cut-off”).
- 1.3 You must complete the qualifying trade for your tier by 23:59 BST on 30 June 2026 (the “Trade Deadline”).
- 1.4 SpaceX is expected to begin trading on the Nasdaq on Friday 12 June 2026 under the ticker SPCX. The listing date is set by SpaceX and its underwriters and may change. If the listing is delayed or does not proceed, we may amend or withdraw this Offer under section 10.

## 2. Eligibility

To take part you must:

- 2.1 Be a new client whose account is approved during the promotion period.
- 2.2 Have never held a funded account with ThinkMarkets. If you hold, or have ever held, a funded ThinkMarkets account, on any entity, you are not eligible.
- 2.3 Make a qualifying first deposit during the promotion period.
- 2.4 Submit a valid claim by the Claim Cut-off (see section 5).

One claim is allowed per client. We identify clients by verified identity, payment method and device. Multiple accounts, shared funding sources or linked devices count as one client. Employees of ThinkMarkets, Introducing Brokers and their connected persons are not eligible.

### 3. The Offer

Fund your account and we will allocate a SpaceX share CFD to it, sized by your first deposit:

First deposit	SpaceX share CFD allocated
\$250 to \$999	0.1
\$1,000 to \$2,499	0.5
\$2,500 to \$4,999	1.5
\$5,000 or more	4.0

The allocation is capped at 4.0 SpaceX share CFDs. Deposits above \$5,000 receive the same 4.0 allocation. Your tier is set by the value of your first deposit and does not change if you deposit again later.

A SpaceX share was priced at around \$135 at the IPO. This figure is indicative only. We allocate a fixed number of SpaceX share CFDs per tier, not a fixed cash value, so the value of your allocation moves with the market price.

### 4. How to claim

- 4.1 Make your first deposit.
- 4.2 Email [support@thinkmarkets.com](mailto:support@thinkmarkets.com) from your registered address, after your deposit and before the Claim Cut-off, stating that you wish to claim the SpaceX Offer.
- 4.3 We process valid claims and allocate the SpaceX share CFD once your deposit has cleared and the SpaceX share CFD is available to trade.

Claims received after the Claim Cut-off are not accepted.

### 5. The allocation

- 5.1 We allocate the SpaceX share CFD as a long (buy) position on your trading account. You hold the position and you carry the market risk on it. The value can rise and fall.
- 5.2 The allocation is locked until you meet the unlock condition in section 7. While it is locked, you cannot withdraw funds without forfeiting it (see section 8).

### 6. Unlocking the allocation

To keep the allocation and lift the withdrawal lock, complete the qualifying trade for your tier by the Trade Deadline:

First deposit tier	Qualifying trade
\$250 to \$999	1 lot of FX or Gold, or 10 SpaceX share CFDs
\$1,000 to \$2,499	2 lots of FX or Gold, or 20 SpaceX share CFDs
\$2,500 to \$4,999	3 lots of FX or Gold, or 30 SpaceX share CFDs
\$5,000 or more	5 lots of FX or Gold, or 50 SpaceX share CFDs

- 6.1 The qualifying trade must be made with your own funds and is separate from the allocation. The SpaceX share CFD we allocate to you does not count towards the qualifying trade.
- 6.2 The qualifying trade must be held open for at least 5 minutes.
- 6.3 Once you complete the qualifying trade, the allocation is yours. The withdrawal lock is lifted and you may hold, close or trade the SpaceX share CFD, and withdraw your funds, as you wish.

## **7. Withdrawals and forfeiture**

- 7.1 If you withdraw any funds before you complete the qualifying trade, we remove the SpaceX share CFD allocation, or its cash value at the time of removal, from your account.
- 7.2 If you do not complete the qualifying trade by the Trade Deadline, we remove the allocation, or its cash value at the time of removal, from your account.

After you complete the qualifying trade, no withdrawal restriction applies under this Offer.

## **8. Anti-abuse**

We may withhold or remove an allocation, and close or restrict an account, where we reasonably believe a client has:

- 8.1 Opened more than one account, or used multiple identities, payment methods or devices, to claim more than once.
- 8.2 Funded an account only to claim and withdraw without genuine trading intent.
- 8.3 Used trades designed to meet the qualifying requirement without market risk, including matched or offsetting positions across accounts.
- 8.4 Provided false information or otherwise abused the Offer.

Our decision on eligibility, qualifying trades and forfeiture is final.

## **9. General**

- 9.1 We may amend, suspend or withdraw this Offer at any time, including if the SpaceX listing is delayed, changed or cancelled, or for legal, regulatory or operational reasons.
- 9.2 This Offer cannot be exchanged for cash except where these terms provide for a cash value on removal.

Where these terms conflict with the Company's general client agreement, these terms apply to this Offer only.

## **10. Governing law**

These Promotion Terms are governed by the same governing law and jurisdiction provisions as the standard Programme Terms applicable to the licensed ThinkMarkets entity with which the client holds their account.

## **11. Risk warning and regulatory information**

Trading CFDs and forex carries a high level of risk to your capital and may not be suitable for all investors. CFDs are complex instruments and come with a high risk of losing money rapidly due to leverage. You may lose more than your initial deposit. Please ensure you fully understand the risks involved and seek independent advice if necessary.
